THE GROUNDS ARE PUBLIC AND SUBJECT TO "FIRST COME, FIRST SERVE" BASIS.

DIRECTIONS:

TURN WEST OFF BROADWAY ON EIGHTH STREET (POST OFFICE IS ON THE NORTHWEST CORNER). FOLLOW EIGHTH STREET PASSING THROUGH HWY 264 JCT CONTINUE ONTO GRAVEL ROAD ENTERING THE CAMP GROUNDS.

FROM HIGHWAY 156, TURN AT THE "LARNED STATE HOSPITAL ROAD" (JUNCTION 264) AND CONTINUE ONE HALF MILE SOUTH, THEN TURN RIGHT (WEST) ONTO GRAVEL ROAD.

DESCRIPTION:

CAMP PAWNEE IS LOCATED WEST OF LARNED ON THE PAWNEE RIVER BEND. THE CAMP HAS LARGE OPEN AREAS WITH TALL TREES FOR TENT CAMPING, ALONG WITH 14 RV CAMP SITES. THERE ARE RESTROOMS AND A WATER FAUCET. WATER MUST BE CARRIED TO CAMP AREAS. CAMPERS SHOULD PLAN TO USE ONLY CHARCOAL FOR COOKING. THERE IS NO WOOD AVAILABLE. CHARCOAL GRILLS MAY BE USED FOR MEETINGS. THE LODGE CONSISTS OF A KITCHEN, A LARGE ROOM AND ONE BATHROOM. THE KITCHEN HAS A SINK, RANGE AND REFRIGERATOR. (DAY CAMP MATERIALS ARE BEING STORED ON SHELVES AT THE END OF THE KITCHEN, PLEASE DO NOT USE). A FEW DISHES AND PANS ARE IN THE KITCHEN, BUT YOU SHOULD PLAN TO BRING ALL YOUR OWN EQUIPMENT. PICNIC TABLES HAVE BEEN PLACED BOTH INSIDE AND OUTSIDE THE LODGE.

CAMP PAWNEE RULES

1. SPEED LIMIT IS 15 MPH ON GROUNDS AND AREA IS PATROLLED BY PAWNEE COUNTY SHERIFF'S OFFICE.
2. CLUBHOUSE AND IMMEDIATE AREA ARE TO BE LEFT CLEAN. FLOOR MUST BE SWEEPED AND SPILLS MOPPED PRIOR TO ANOTHER PERSON TAKING CONTROL OF THE CLUBHOUSE. RESTROOM IN THE CLUBHOUSE NEEDS TO BE CLEANED IF NECESSARY.
3. KEYS NOT RETURNED WILL RESULT IN FORFEITURE OF YOUR DEPOSIT PLUS COST OF HAVING LOCKS CHANGED.
4. ADDITIONAL RESTROOMS AVAILABLE OUTSIDE.
5. ALL CAMPFIRES SHALL BE IN THE AVAILABLE FIRE RINGS. NO OPEN FIRES DURING A "BURN BAN". NO PALLETS ARE ALLOWED TO BE BURNED. ALL FIRES TO BE EXTINGUISHED PRIOR TO LEAVING.
6. SOME CLEANING SUPPLIES ARE AVAILABLE, AS WELL AS SOME UTENSILS BUT YOU SHOULD PLAN ON HAVING YOUR OWN WITH YOU. A RANGE, REFRIGERATOR AND MICROWAVE ARE IN THE CLUBHOUSE. REFER TO CHECKLIST.
7. DISORDERLY CONDUCT, ALCOHOLIC BEVERAGES AND /OR ILLEGAL DRUGS ARE NOT ALLOWED
8. REPORT ANYTHING THAT NEEDS TO BE REPLACED OR REPAIRED ON THE CHECK LIST, WHICH MUST BE RETURNED TO THE COUNTY CLERK'S OFFICE WITH ALL KEYS.
9. DEPOSIT WILL NOT BE RETURNED UNTIL THE COMPLETED CHECKLIST AND KEYS HAVE BEEN RETURNED. THE CARETAKER WILL INSPECT AND APPROVE THE AREA (GROUNDS/BUILDING) PRIOR TO THE DEPOSIT BEING RELEASED.
10. NO DRIVING/PARKING ON SIDEWALKS OR GRASS ALLOWED. VEHICLES ARE TO STAY ON ROADS AND SANDED AREA AT ALL TIMES.

NOTICE

Any groups over 200 people renting Camp Pawnee are now required to provide portable toilets. You will need at least 2 portable toilets per 100 people. (i.e. 200 people would need 4 portable toilets, 300 people would need 6 portable toilets). If the group is 200 or less people no portable toilets will be required.
