

**RESOLUTION NO. 2001-04**

**A RESOLUTION RELATING TO THE CREATION OF A PLANNING COMMISSION FOR PAWNEE COUNTY, KANSAS; APPOINTING PERSONS TO SERVE ON SAID PLANNING COMMISSION; SETTING LENGTH OF TERMS FOR SAID APPOINTEES; AND CALLING THE FIRST MEETING FOR SAID PLANNING COMMISSION.**

**WHEREAS, the Board of County Commissioners of Pawnee County, Kansas, is concerned with the potential impacts of land use changes on neighboring properties and the community as a whole; and,**

**WHEREAS, Kansas statutes authorize the Board of County Commissioners of Pawnee County, Kansas, to address these concerns by exercising its authority to establish a Planning Commission and adopt Zoning Regulations which regulate the use of land in the unincorporated Portion of Pawnee County, Kansas;**

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PAWNEE COUNTY, KANSAS, THAT:**

1. In accordance with Article 7, Chapter 12, of the Kansas Statutes Annotated, a Planning Commission for the Pawnee County, Kansas, is hereby created. Said Planning Commission shall consist of nine (9) persons appointed by the Board of County Commissioners; a majority of whom shall be residents of the unincorporated portion of Pawnee County. Of the persons first appointed herein, three (3) shall be appointed for a term of one (1) year, three (3) shall be appointed for a term of two (2) years, and three (3) shall be appointed for a term of three (3) years. All persons appointed thereafter shall be appointed for a term of three (3) years. Vacancies shall be filled by appointment for the unexpired term. Persons appointed to the Planning Commission shall serve without compensation for their service.

2. The following persons are hereby appointed to the Pawnee County Planning Commission:


Stejskal, Donna shall be appointed for a term to expire on August 30, 2003.

4. This resolution shall be in full force and effect from and after is passage and publication in the official County newspaper.


