Kurt Demel, Co. Hwy. Adm. Showed some pictures of work being done. County doing the work would save \$10,000. Demel said his crew can do this with their loader.

Budget hand out shows \$100,000 carry over. Demel stated it is getting back to where it should be, \$150,000. Even if it starts snowing, should still have carry over. Phase 2 & 3 paid out. Even if FFE couldn't do the \$66,000, R & B can still cover it, \$200,000 going back in general, additional cash there if we need.

Motion by Lewis to move forward with Barton County/Pawnee County Road drainage project is what Demel is calling it, Rein wants to clear it will be paid out of R & B budget. Rein seconded. Hammeke approved. \$15,000 coming out of 2018 budget. \$200,000 estimated cost of resurfacing Rozel Bridge, Demel is going to at least try filling it in.
